This year we are having only two fee structures Rs. 1700/- and Rs. 1800/-. Please refer to first line of circular for your ward's transport fee.

The fee hike is marginal and is the need of the hour as diesel charges and utility charges of all essential services like maintenance of the buses have been hiked. 1. Fee will only be collected as Cheque or DD in favour of <u>'Matrusri D A V Public School'</u>. Cash will not be entertained.

2. In-Case of Transport fee cheque rejects, penalty of Rs. 300/- will be charged.

3. Once a cheque is rejected, Next fee payment will only be accepted as Demand Draft.

4. Kindly preserve receipt with you carefully. In-case the school authorities require it for any reference; the parent should be able to produce the same.

5. No fee collection on Second Saturday, Fourth Saturday & Bank holidays.

6. Pay the correct amount as mentioned in the fee circular. Please write the Students name, Admission number, Class/sec, Mother/Father mobile no., Bus Numbers, on the reverse side of the cheque.

7. Parent must obtain the receipt from the fee counter at the time of fee payment. The school is not responsible for any payment without receipt. Fee card is compulsory during the payment of fee.

8. As there is no separate transport fee card, regular fee card must be carried/sent along for payment of transport fee.
